There are four Rebounder Executive Offices:

President - presides at all meetings and performs all duties generally performed by presidents as well as such duties as the Executive Committee may assign.

Vice-President - performs the duties of an absent President and carries out such duties as are assigned by the President.

Secretary - records the minutes of all proceedings of the Executive Committee and membership meetings and carries out such duties as assigned by the President or Executive Committee.

Treasurer - organizes a fund raising event each year, if necessary, and performs such duties as assigned by the President or Executive Committee.

Current officers are eligible to run for re-election to their current position or for a different position on the Board. All offices are open at the end of each two-year term to all Rebounders who are currently members in good standing.
